Rate Affordability Task Force Meeting #6

Overview

The task force, appointed by Hamilton County Board of County Commissioners, held its fifth meeting to discuss rate structures for the Greater Cincinnati Metropolitan Sewer District (MSD). The task force, chaired by Madeira City Manager Thomas Moeller, includes 15 diverse members representing local governments, business owners, homeowners, renters, senior citizens, low-income residents, environmental groups, and non-profit organizations. The purpose of this task force is to provide the Commissioners with recommendations to mitigate ratepayer fee increases by April 2016.

Summary

For the sixth publicly-held meeting, 20 total individuals were present including the task force and non-task force members listed on the following page. To begin the meeting, Tom Moeller offered a quick welcoming including reminder regarding the task at hand. Next, a group discussion was facilitated by Steven Johns, Planning Services Administrator at Hamilton County Regional Planning.
