RESOLUTION NO. 25

A RESOLUTION AUTHORIZING A REDUCTION IN CERTAIN PROPERTY OWNERS  
PROPERTY TAXES FOR CALENDAR YEAR 2009

BY THE BOARD:

WHEREAS, the voters of Hamilton County approved an increase in the County sales tax of ½% on March 19, 1996; and

WHEREAS, the Board of County Commissioners committed to using 30% of the proceeds of the dedicated sales tax for property tax reduction; and

WHEREAS, the Board of County Commissioners estimate that there will be approximately \$19,300,000 of the dedicated sales tax proceeds available for property tax reductions in calendar year 2009 after adjustments for actual collections of the dedicated sales tax for the period July 2007 through June 2008 and estimating collections for the period from July 2008 through June 2009.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Hamilton County, Ohio that thirty percent (30%), approximately \$19,300,000, of the proceeds from the dedicated ½% sales tax is to be used for property tax reductions from the 2008 tax year payable in the calendar year 2009.

BE IT FURTHER RESOLVED that the Clerk of the Board be and hereby is authorized and directed to certify copies of this resolution to Patrick Thompson, County Administrator; Christian Sigman, Assistant County Administrator; Dusty Rhodes, County Auditor; and Richard A. Levin, Tax Commissioner, State of Ohio.


