Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Port of Greater Cincinnati Development Authority Board of Directors**, has an open position for a Board member.

I invite you to consider applying to be a member on this important Board which serves as the primary entity in Hamilton County facilitating the redevelopment of brownfield sites through acquisition of Clean Ohio grants as well as secures financing for various development projects through the issuance of revenue bonds. The Port Authority is also the operating agent for the County Land Reutilization Corporation and is taking a leadership role in spurring improvements to the County's intermodal transportation network and exploration of a public port. The appointee would serve an unexpired term due to a Board member's resignation, to expire November 6, 2016.

The open position on the Port Authority Board of Directors must be filled by a County resident. In the coming weeks, Commissioners will be collecting and reviewing applications for this Board in anticipation of appointment at our February 11, 2015 meeting.
