The Hamilton County Auditor's office provides the support staffing for scheduling, resolving and clerical requirements of the Board. All appointees will serve a term that ends on December 31, 2012.

As with all of the Boards that the Hamilton County Commissioners appoint to, the open position on the Hamilton County Board of Revision must be filled with a County resident in order to provide a representative and accountable decision-making body for the activities of this important economic development entity. In the coming weeks, Commissioners will be collecting and reviewing applications for the Hamilton County Board of Revision in anticipation of appointment at our February 8 Commissioners' meeting.
