## Memorandum

**TO:** Hamilton County Residents

**RE:** Hamilton County Regional Planning Commission

Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Hamilton County Regional Planning Commission**, has an open position for **one (1)** Board member. **The appointee would serve a term ending March 6, 2021.**

Established by the adoption of a Resolution of Cooperation by the Board of County Commissioners (BOCC), the Planning Commissions of Municipalities and the Boards of Trustees of Townships within Hamilton County, and in accordance with the laws of the State of Ohio, particularly Section 713.21 et seq. of the Ohio Revised Code, the Regional Planning Commission (RPC) shall have the power and duty to make studies, maps, plans, recommendations, and reports concerning the physical, environmental, social, economic, and governmental characteristics, functions, services, and other aspects of the region or county.

The composition of the RPC shall consist of four (4) residents of the unincorporated area in Hamilton County (appointed by the BOCC from nominations by Township Trustees) and three (3) residents of municipalities including:

- 1) One (1) resident from Cincinnati (appointed by the Cincinnati Planning Committee)
- 2) One (1) member of a village or city planning commission exclusive of Cincinnati (elected by mail ballot by village and city planning commissions, exclusive of Cincinnati)
- 3) One (1) resident of a city or village that has a planning commission (appointed by the Board of County Commissioners); and

The BOCC shall attempt to achieve a geographical balance among appointees from the unincorporated area. Each appointment shall be for terms of five (5) years. As with all of the Boards to which the Hamilton County Commissioners appoint, the appointees must be a Hamilton County resident.
