**RE:** Hamilton County Regional Planning Commission

Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Regional Planning Commission**, has two open positions.

The Regional Planning Commission is responsible for determining consistency of development proposals with adopted plans for township areas, as well as development review for consistency with zoning regulations, subdivision rules, and thoroughfare plans. Additionally, the Regional Planning Commission takes final actions on land subdivision for all unincorporated areas in Hamilton County.

The current openings on the Regional Planning Commission are for Hamilton County residents who meet one of the following criteria:

- 1) a resident from an incorporated City or Village with a planning commission, outside the City of Cincinnati;  
or
- 2) a resident from an unincorporated jurisdiction of Hamilton County.

Both positions on the Regional Planning Commission are for five-year terms to expire March 6, 2020. In the coming weeks, Commissioners will be collecting and reviewing applications for the Regional Planning Commission in anticipation of appointment at our March 11 Commissioners' meeting.
