Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Southwestern Ohio Regional Transit Authority (SORTA) Board of Directors**, has **three open positions**.

I invite you to consider applying to be a member on this important Board, which oversees the activities of SORTA and governs Metro, the local fixed-route bus transportation service. The appointees would serve terms that end on January 30, 2018.

As with all of the Boards that the Hamilton County Commissioners appoint to, the three open positions on the SORTA Board of Directors must be filled with a County resident in order to provide a representative and accountable decision-making body to shape local transportation policy. In the coming weeks, Commissioners will be collecting and reviewing applications for the SORTA Board of Directors in anticipation of appointment at our March 25<sup>th</sup> Commissioners' meeting.
