RE: Hamilton County Rural Zoning Commission

Commissioners have the responsibility to appoint members to several boards and commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these boards, the **Hamilton County Rural Zoning Commission has openings for two (2) board members.**

I invite you to consider applying to be a member on this board. The purpose of the Rural Zoning Commission is to submit a plan, including both text and maps, representing the recommendations of the Zoning Commission for the carrying out by the Board of County Commissioners (BOCC) of the powers, purposes, and provisions set forth in Sections 303.01 to 303.99 of the Ohio Revised Code, including additions to territory in which a county zoning plan is in effect.

The Hamilton County Rural Zoning Commission is established by the Ohio Revised Code, Section 303.04 and by Resolution by the Board of County Commissioners approved on May 21, 2003. The Board of County Commissioners of any county proceeding under sections 303.01 to 303.25 of the Ohio Revised Code shall create and establish a county rural zoning commission. Each regular or alternate member shall serve until the member's successor is appointed and qualified. The terms of the regular members shall be of such length and so arranged that the term of one member will expire each year.

At this time there are openings for two (2) board members to fill terms to expiring October 15, 2019.
