## Memorandum

**RE:** Board of Trustees of the Zoological Society of Cincinnati

Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Board of Trustees of the Zoological Society of Cincinnati** has an open position for one (1) trustee.

I invite you to consider applying to be a member on this board whose purpose is to ensure the integrity and longevity of the best zoos in the nation. Established by the Code of Regulations of the Zoological Society of Cincinnati, the composition of this board shall be thirty-two (32) trustees selected as follows: twenty-six (26) Trustees shall be elected by the members of the Society; three (3) Trustees shall be appointed by the Cincinnati City Council and three (3) trustees shall be appointed by the Hamilton County Board of County Commissioners (BOCC).

Each member shall serve a term of three (3) years until each such trustee's successor is duly elected or appointed or until each such trustee's earlier resignation, removal from office, or death. No person who has been elected as trustee by the members of the society and who has

served as a trustee for three (3) consecutive three-year terms shall be eligible for re-election to a fourth consecutive term, provided, however, that such limitation shall not apply to any trustee who holds elective office during the terms of office of such trustee. **At this time there is an opening for one (1) trustee, term ending September 14, 2019.**
