RE: Port of Greater Cincinnati Development Authority

Commissioners have the responsibility to appoint members to several Boards and commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Port of Greater Cincinnati Development Authority, has an open position for a board member.**

The purpose of this board is to implement the redevelopment of the Riverfront and continue the efforts of brownfields redevelopment in Cincinnati and Hamilton County. The Ohio Revised Code Section 4582.22 authorizes counties and municipal corporations to act jointly to create a "Port Authority" as defined in those sections. The Board of County Commissioners (BOCC) of Hamilton County, Ohio, Resolution (Volume 280, Image 5-15) dated October 4, 2000, approved an agreement for the creation of a new Port Authority between the BOCC of Hamilton County and the City of Cincinnati and amended and restated by resolution adopted August 13, 2008.

The members of the board of directors of the Port of Greater Cincinnati Authority shall number ten (10), of whom five (5) shall be appointed by the Mayor of the City with the advice and consent of City Council, and five (5) shall be appointed by the BOCC. Members shall serve for a term of four (4) years, except that any person appointed to fill a vacancy shall serve only for such unexpired term. **At this time there is an opening for one board member, term to expire December 31, 2017.**
