RE: Tax Incentive Review Council (TIRC)

Commissioners have the responsibility to appoint members to several Boards and commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Tax Incentive Review Council (TIRC)** has **4-5 open positions for board members**.

I invite you to consider applying to be a member on this board. Established by Ohio Revised Code Section 5709.85, the TIRC's purpose is to designate areas as Enterprise Zones or Community Reinvestment areas and to execute agreements with certain enterprises for the purpose of establishing, expanding, renovating or occupying facilities and hiring new employees and preserving jobs within said zones or areas in exchange for specified local tax incentives granted by the county. In addition, to review all outstanding agreements to determine whether the enterprises are in compliance in terms and to make recommendations to the Board of County Commissioners regarding said agreements.

Each member shall be appointed for a term of one year, commencing the first day of January. **At this time there are openings for 4-5 board members, terms to expire December 31, 2014.**
