RE: Rural Zoning Commission

The appointee would be the Board's Miami Township representative and would serve a term that ends on October 19, 2017.

The open position on the Rural Zoning Commission must be filled with a County resident in order to provide a representative and accountable decision-making body for this important County function. In the coming weeks, Commissioners will be collecting and reviewing applications for the Rural Zoning Commission in anticipation of appointment at our October 17 Commissioners' meeting.
