**RE:** Cincinnati Metropolitan Housing Authority (CMHA)

Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, **the Cincinnati Metropolitan Housing Authority (CMHA) has two (2) openings: one (1) board member position and one (1) board member representing the Hamilton County Municipal League as mandated by an amendment to the Ohio Revised Code, Section 3735.27 effective September 6, 2012.**

I invite you to consider applying to be a member on this board which serves as the primary entity to make all operational and budgetary decisions regarding the use of federal funds allocated for housing in accordance to the Ohio Revised Code, Section 3735.69.

Established in December of 1993 under the provisions of the Ohio Housing Authority (Ohio Revised Code, Section 3725.27(A)—Ohio Housing Authority Law), each board member shall serve a term of five (5) years without compensation.

At this time there are two (2) openings: one (1) as a board member and one (1) board member representing the Hamilton County Municipal League as mandated by an amendment to the ORC, Sec 3735.27—each term to expire December 30, 2019.
