## Memorandum

**RE:** Tax Incentive Review Council (TIRC)

Commissioners have the responsibility to appoint members to several Boards and commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Tax Incentive Review Council (TIRC)** has **several positions available: three (3) to serve as board members and two (2) to serve as alternates.**

I invite you to consider applying to be a member of this board. Established by Ohio Revised Code Section 5709.85, the TIRC's purpose is to designate areas as Enterprise Zones or Community Reinvestment areas and to execute agreements with certain enterprises for the purpose of establishing, expanding, renovating or occupying facilities and hiring new employees and preserving jobs within said zones or areas in exchange for specified local tax incentives granted by the county. In addition, to review all outstanding agreements to determine whether the enterprises are in compliance in terms and to make recommendations to the Board of County Commissioners regarding said agreements.

Each member shall be appointed for a term of one (1) year, commencing the first day of January. **At this time there are openings for three (3) board members and two (2) to serve as alternates each term ending December 31, 2017.**
