I invite you to consider applying to be a member on this important Board, which reviews requests from healthcare organizations that wish to finance capital expenditures through the sale of hospital facilities revenue bonds, and makes recommendations to the Board of Commissioners.

As with all of the Boards that the Hamilton County Commissioners appoint to, open positions on the Hamilton County Hospital Commission must be filled with County residents in order to provide a representative and accountable decision-making body. In the coming weeks, Commissioners will be collecting and reviewing applications for the Hamilton County Hospital Commission in anticipation of appointment at our December 16<sup>th</sup> Commissioners' meeting.
