The open position on the Board of Building Appeals must be filled with a County resident in order to provide a representative and accountable decision-making body for this important community function. In the coming weeks, Commissioners will be collecting and reviewing applications for the Board of Building Appeals in anticipation of appointment at our November 28 Commissioners' meeting.
