RE: Hamilton County Hospital Commission

Commissioners have the responsibility to appoint members to several Boards and Commissions, providing oversight to many important organizations and initiatives in Hamilton County. One of these Boards, the **Hamilton County Hospital Commission**, has four positions set to expire on December 31, 2011.

I invite you to consider applying to be a member on this important Board, which reviews requests from healthcare organizations that wish to finance capital expenditures through the sale of hospital facilities revenue bonds, and makes recommendations to the Board of Commissioners. The open positions must be filled by residents who meet the following criteria:

1. One member representing the public. Term ends December 31, 2017;
2. One member representing the Health Alliance. Term ends December 31, 2017;
3. One member representing the Hospital Commission. Term ends December 31, 2017; and
4. One member representing Mercy Health Partners. Term end December 31, 2017.

As with all of the Boards that the Hamilton County Commissioners appoint to, these open positions on the Hamilton County Hospital Commission must be filled with County residents in order to provide a representative and accountable decision-making body for this important County function. In the coming weeks, Commissioners will be collecting and reviewing applications for the Hamilton County Hospital Commission in anticipation of appointment at our December 21 Commissioners' meeting.
