Hamilton County Neighborhood Stabilization (NSP)

Homebuyer Assistance Program

The NSP Homebuyer Assistance Program helps income-qualified buyers in the purchase of foreclosed, abandoned, or vacant homes that have been rehabilitated with NSP funds.

Approved applicants are eligible to receive grants up to \$14,999 to be used as down payment assistance.

Program Specifications

- Grants are in the form of a forgivable loan (soft second mortgage)
- 0% interest
- Household annual gross income must not exceed 120% AMI (see table on the bottom right)
- Grant amount is based on income (see table on the top right)
- Home must be owner-occupied for 5 years (affordability period)
- Applicant may be a repeat or first-time home buyer

Income Range	Grant Amount
Below 80% AMI	\$14,999
80% - 100% AMI	\$12,500
Over 100% -120% AMI	\$10,000

Other Specifications

- Applicant must complete a 9-hour class offered by The Home Ownership Center
- First mortgage must be a fixed rate
- Maximum 31% housing ratio
- Maximum 43% total debt ratio
- Buyer must contribute a minimum of half the lender required down payment towards purchase
- Eligibility should be confirmed prior to signing purchase contract
