If work done under this permit involves or endangers structures belonging to others, I shall immediately notify the owner.
- This permit may at any time be revoked or annulled by the County Engineer's Office for non-performance and/or not compliance with any of the conditions, restrictions and or regulations. Violations of, or non-compliance of said regulations are subject to penalties provided by Sections 5589.10 and 5591.26 of the Ohio Revised Code.
- At all times during the progress of the work, the permit holder shall provide adequate protection and passage for the traveling public.
- All pavement openings must be filled or plated if they are to be left unattended; however, longitudinal openings of major proportions may be left open when certain procedures are followed. The exception does not apply to "RESTRICTED" roads where full width of pavement must be open from 7:00 to 9:00 A.M. and 4:00 to 6:00 P.M.

Plans and/or applications must be approved, and permit secured before commencing work. County regulations require that you notify the County Engineer's Office forty-eight (48) hours before starting construction (between 7:30 A.M. and 9:30 A.M.) - call 946-8430. The office is located at 223 W. Galbraith Rd. Cincinnati, OH 45215 (behind Drake Hospital). APPLICATION FEES ARE NON-REFUNDABLE.
