

The Ohio Department of Transportation (ODOT) has determined that the Disadvantaged Business Enterprise (DBE) goal for this project is **eight percent (8 %)**.

Detailed information for the work may be obtained at the office of the County Engineer.

ONLY contractors pre-qualified by the Ohio Department of Transportation (ODOT) are eligible to submit bids for this project. Pre-qualification status **MUST be in force at the time of submitting the bid, at the time of the award and through the life of the construction contract**. For work types that ODOT does not pre-qualify, the LPA will still select a qualified contractor. Subcontractors are not subject to the pre-qualification requirement. The "prime" contractor **MUST** perform **no less than fifty (50) percent** of the total original contract price.

Each proposal must be accompanied by a one hundred percent (100%) bid guaranty bond or a certified check, cashier's check or letter of credit on a solvent bank in an amount equal to ten percent (10%) of the bid.

Bidders must use the printed forms provided herein.

The bidder to whom the Contract is awarded will be required to furnish a Corporate Surety Company Bond in a sum equal to one hundred percent (100%) of the total bid price, conditioned according to law.

The County Commissioners reserve the right to reject any or all bids, or accept or reject any part thereof.
