**RESOLUTION ESTABLISHING THE ORAL HEALTH COALITION OF
HAMILTON COUNTY**

WHEREAS, Hamilton County Public Health and Board of County Commissioners has established The Oral Health Coalition to engage the dental community, healthcare and others in addressing pressing oral health needs among Hamilton County residents.

WHEREAS, the basis for this request is the 2015 Health Management Associates Report for Hamilton County, Ohio Oral Health Needs Assessment and Recommendations to Inform a Strategic Plan. The need is as follows:

- 36 percent of adults in Hamilton County between 19 – 64 years of age did not have dental insurance
- More than 11,000 dental-related emergency department visits
- The Hamilton County rate of 1,339 adult ED visits per 100,000 population is nearly 65% higher than the national rate of 857 despite dentist to population ration is better than that of the U.S. as a whole

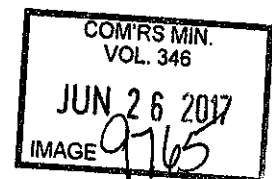
THEREFORE, BE IT RESOLVED that the Oral Health Coalition shall have the following functions and duties associated:

- Produce a strategic plan with measurable goals and objectives
- Increase dental capacity and access for Medicaid and low income uninsured populations
- Improve overall oral hygiene of population
- Work to implement the recommendation from Health Management Associates to develop a collaborative and contractual relationship between Hamilton County Dentists and Federally Qualified Health Centers (FQHC) in Hamilton County.

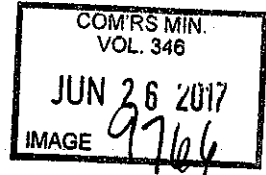
THEREFORE, BE IT FURTHER RESOLVED that the Board of County Commissioners of Hamilton County, Ohio does call upon the Hamilton County General Health District to host the Oral Health Coalition and its activities for the balance of 2017.


