River City Correctional Center continually strives to improve its efforts with deterring acts of sexual harassment and abuse perpetrated against its facility residents. River City has imposed disciplinary action—up to and, including termination—for those staff who have violated agency sexual harassment and/or sexual abuse policies. With respect to resident-on-resident acts of sexual harassment and abuse, River City has imposed disciplinary action commensurate with the offence. Moreover, those residents who remained in the River City program after violating facility PREA guidelines were offered additional behavior modification therapy—and enhanced monitoring—to aid them with compliance

Additionally, River City continues to review for additional cameras, which will be installed in areas of the facility where there are currently blind spots.
